His current wife was affectionally adopted "Ma Christien" by me. She was a lovely lady and I continued to share a relationship with her after my biological dad's death on the 16th November 2018 and up to her death in 2021.

Regrettably, My Dad was suffering with Severe Diabetes which developed into Dementia in his last years. I never found out if his 1st wife, Suzanna was my biological mother or not.

Regrettably, Susanna passed away before I met my Biological Father.

I did, however, learn from my eldest Brother who was born from my Dad Gustav & Susanna that he remembers a young girl staying with them for several years before she disappeared. Referring to me of course.
